"TO: All BMW Motorcycle Dealers  
RE: Recall 84V-092 -- Front Cast Wheels

The mailing of customer notification letters is now in progress; therefore, this campaign has officially started.

A recall authorization form with customer name and VIN number is part of this notification.

## PROCEDURE:

1. Customers will contact you for an appointment.
2. Proceed according to S.I. NR. 36 022 (2117), August, 1984.
3. The authorization form must be presented by the customer.
4. After the inspection/repair is completed, customer and yourself must sign this form, along with the date of completion.
5. Attach the top copy, marked "BMWNA - Copy No. 1", to your work order file copy. The remaining copies of this form can be destroyed.
6. Submit a special campaign claim to our Warranty Department for each action.

NOTE: DO NOT ATTACH THE AUTHORIZATION FORM TO THE CAMPAIGN CLAIM.

In case a customer has not received a notification letter, but is entitled to replacement/inspection, proceed as follows:

- A. Check the validity of the customer's request.
- B. Issue a work order, identify "Recall Campaign 84v-092" action, and correct VIN number.
- C. After completion of the necessary job, the customer must sign the work order.
- D. Submit a special campaign claim accordingly.

SUMMARY:

For reimbursement, only campaign claims are accepted.

It is your duty to collect and store the authorization forms and/or signed work order.


